TERMS AND CONDITIONS OF AGREEMENT

1. In consideration of South Florida Contractor Services Inc. providing Notice to Owner services and other services, the above named customer agrees to pay its monthly statements within 10 days of the statement date. If payment is not made within terms, the above named customer agrees to pay interest of 1 1/2 % per month. If it becomes necessary to effect collection, the above named customer agrees to pay all costs of collection, including reasonable attorney's fees. It is agreed that proper venue for suit to collect any outstanding balance shall be in Broward County, Florida.
2. The above named customer understands that South Florida Contractor Services, Inc. is not an insurer and any payments received are based solely upon the value of the services described and it is not the intention of the parties that South Florida Contractor Services, Inc. assume responsibility for any loss occasioned by malfeasance or misfeasance in the performance of the services under this contract or for any loss or damage sustained by virtue of the relationship herein established. If there shall, at any time, be or arise any liability on the part of South Florida Contractor Services, Inc. or otherwise, such liability is and shall be limited to the errors and omissions on its liability policy. Such liability as herein set forth is fixed as liquidated damages and not as penalty and such liability shall be complete and exclusive.
3. The customer understands that, aside from the information furnished by him, South Florida Contractor Services, Inc. may or may not be able to determine who to send copies of the Notice to Owner to. The customer hereby waives and claims against South Florida Contractor Services, Inc. that exist now or that may arise in the future because of the failure of South Florida Contractor Services, Inc. to ascertain who should receive copies of the Notice to Owner.

Because of the varied informational sources upon which South Florida Contractor Services, Inc. must rely, and over which South Florida Contractor Services, Inc. has no control, the customer acknowledges that South Florida Contractor Services, Inc. does not and cannot guarantee or warrant the correctness, completeness, currentness, or fitness of the information furnished to the customer. It is further understood and agreed to that South Florida Contractor Services, Inc. in furnishing the information, does not and cannot underwrite the customer's risk, in any manner whatsoever.

South Florida Contractor Services, Inc. shall not be bound by any agreement or contract in existence prior to the date of this agreement and customer hereby releases South Florida Contractor Services, Inc. from any liability existing prior or subsequent to the signing of this agreement. No waiver, or amendment of this agreement shall be binding on South Florida Contractor Services, Inc. unless in writing, signed by an authorized official of South Florida Contractor Services, Inc.
